

At our regularly held public meeting on September 11, 2007, the Board of Directors of the Downtown Los Angeles Neighborhood Council (“DLANC”) voted to support the above CUB application for the restaurant projects at 888 S. Figueroa Street, pursuant to the motion passed on August 22, 2007 by DLANC’s Planning & Land Use Committee.


In particular, DLANC encourages the City to grant the approvals requested by the applicant, including a conditional use permit pursuant to L.A. Municipal Code section 12.24-W1 for the sale and dispensing of a full line of alcoholic beverages for on- and off-site consumption at the proposed three restaurants, café and two gourmet shops. DLANC supports the planned development of ground floor, neighborhood-serving restaurants and markets, subject to input from the Los Angeles Police Department, the 9<sup>th</sup> District Council Office and South Park Stakeholders Group regarding the appropriate hours for off-site liquor sales.
