- a) **Potential Action to Issue CIS on CF 20-0002-S127**  
 Proposition 16 / Government Agency Preferential Consideration / Employment, Contracting, and Education / Race, Sex, Color, Ethnicity, or National Origin: Introduced on August 05, 2020 and referred to Rules, Elections, and Intergovernmental Relations Committee. The Resolution is requesting the City of Los Angeles to include in its 2019-2020 State Legislative Program SUPPORT for Proposition 16 which would allow government agencies to give preferential consideration based on race, sex, color, ethnicity, or national origin in employment, contracting, and education..
  - b) **Potential Action to Issue CIS on CF 20-0002-S128**  
 HR 6721 (Meng) / The COVID-19 Hate Crimes Act / Department of Justice Oversight / COVID-19 Related Hate Crimes: Introduced on August 05, 2020 and referred to Rules, Elections, and Intergovernmental Relations Committee. The Resolution is requesting the City of Los Angeles to include in its 2019-2020 Federal Legislative Program SUPPORT for HR 6721, the COVID-19 Hate Crimes 11 Act, which would require the Attorney General to designate a Department of Justice officer or employee to provide greater oversight of COVID-19 related hate crimes.
  - c) **Potential Action to Issue CIS on CF 20-0002-S130**  
 H.R. 35 (Rush) / The Emmett Till Antilynching Act: Introduced on August 11, 2020 and referred to Rules, Elections, and Intergovernmental Relations Committee. The Resolution is requesting the

- City of Los Angeles to include in its 2020-2021 Federal Legislative Program SUPPORT for H.R. 35, the Emmett Till Antilynching Act, which would make lynching a Federal crime.
- d) **Potential Action to Issue CIS on CF 20-0002-S135**  
 SB 731 / Stateside Process / Peace Officer Status Revocation / Police Misconduct Investigation / California Department of Justice / Civil Rights Laws.: Introduced on August 13, 2020 and referred to Rules, Elections, and Intergovernmental Relations Committee. The Resolution is requesting the City of Los Angeles to include in its 2019-2020 State Legislative Program SUPPORT for SB 731 (Bradford), which would create a statewide process to revoke the peace officer status of individuals convicted of certain serious crimes or terminated from employment as a peace officer due to misconduct, and empower the California Department of Justice to investigate allegations of police misconduct and strengthen existing California civil rights laws to prevent law enforcement abuses.
  - e) **Potential Action to Issue CIS on CF 20-0997**  
 Temporary Redemption Fee Waiver / Low-Income Residents / COVID-19 Pandemic: Introduced on August 14, 2020 and referred to Personnel and Animal Welfare Committee. Department of Animal Services report, dated August 11, 2020, is relative to a request for authority to temporarily waive redemption fees for low income residents negatively impacted by the COVID-19 pandemic.
  - f) **Potential Action to Issue CIS on CF 20-0970**  
 Women's Pay and Representation / City of Los Angeles Workforce / Gender Equity / Pay Gap: Introduced on August 5, 2020 and referred to Immigrant Affairs, Civil Rights, and Equity Committee; Personnel and Animal Welfare Committee. Controller report dated August 5, 2020 is relative to closing the gap for women's pay and representation in the City's workforce.
  - g) **Potential Action to Issue CIS on CF 20-0990**  
 Diversity, Equity, and Inclusion Training / Anti-Bias Training / Los Angeles Neighborhood Council Members: Introduced on August 11, 2020 and referred to Health, Education, Neighborhoods, Parks, Arts, and River Committee. The motion is instructing the Department of Neighborhood Empowerment in consultation with the Board of Neighborhood Commissioners, the Civil and Human Rights Department and the Civil and Human Rights Commission, to report back to the City Council regarding a plan to implement the Mayor's Executive Order No. 27 regarding racial equity in city government plans at the Neighborhood Council level.
  - h) **Potential Action to Issue CIS on CF 20-0963**  
 Neighborhood Council Elections / Fiscal Year 2020-21 / COVID-19 Pandemic: Introduced on August 3, 2020 and referred to Health, Education, Neighborhoods, Parks, Arts, and River Committee. Committee approved item on August 13, 2020. City Clerk report, dated August 3, 2020, is relative to the conduct of Neighborhood Council elections during the COVID-19 pandemic.
  - i) **Potential Action to write a Letter regarding ADA Compliance to Appropriate City Agencies.**
    - i) On August 18th, The Venice Neighborhood Council passed a resolution to call on appropriate City Agencies to enforce ADA civil rights laws to protect disabled constituents identified under P.L. 101-336. In this resolution, the VNC asked for items blocking the passage for the disabled to be cleared or moved back a minimum of three feet to comply with the requirements under the Americans With Disabilities Act and to in areas where such compliance are deemed impossible to be met, for these encampments to be relocate to areas where the City can assess to be

appropriate.

- The Downtown Los Angeles Community has worked to accommodate all constituents from all social-economic levels, but in no ways can we allow our disabled constituents to continue to be discriminated against from being able to conduct their daily activities. Allowing the blocking of the Public-Right-of-Way is a violation of their Civil Rights and should be corrected immediately.
- Therefore, this motion proposes for a similar letter to be drafted by the Government Liaison Committee addressed to the appropriate City Agencies.

Prohibit and Suspend / Certificate of Occupancy / Local Hotels / Housing and Detention / Migrant Children and Families / Private Security companies / Ordinance: Introduced on August 18, 2020 and referred to Planning and Land Use Management Committee. Motion is requesting the City Attorney to prepare and present an ordinance that would prohibit, and suspend, any certificate of occupancy for any hotel in Los Angeles which is being used to house and detain migrant children and families under the direction of private security companies.
- g) **Potential Action to Issue CIS on CF 20-1032**  
COVID-19 / Municipal Liquidity Facility Loan Assistance / Rent and Utility Related Debt Forgiveness / Program Structure and Implementation: Introduced on August 18, 2020 and referred Ad Hoc Committee on COVID-19 Recovery and Neighborhood

- Investment. Motion is instructing the City Administrative Officer, with the assistance of the Housing and Community Investment Department to report to Council on the feasibility of applying for Municipal Liquidity Facility loan assistance in order to provide rent forgiveness to those within the City of Los Angeles who have been impacted by COVID-19, as well as with a cost analysis and options for potential program structure and implementation.
- h) **Potential Action to Issue CIS on CF 20-0002-S138**

The Resolution is requesting that the City of Los Angeles include in its 2019-2020 federal Legislative Program SUPPORT for H.R. 7015 and other actions which may be proposed to properly fund the United States Postal Service and halt and/or reverse all managerial and operational changes until Congress, the USPS Board of Governors and the Postal Regulatory Commission have been able to fully review and take action on such proposals.
  - i) **Potential Action to Issue CIS on CF 20-1087**  
Vote-By-Mail Expansion / Ballot Drop Boxes Installation / COVID-19 Pandemic / Safe Voting Access / Universal Suffrage: Introduced on August 26, 2020 and referred to Rules, Elections, and Intergovernmental Relations Committee. Motion is instructing the City Clerk to report to Council on the feasibility of installing ballot drop boxes in city facilities to ensure voters have easy and safe access to cast their ballots, including security for drop box locations and a process to ensure all ballots deposited at a drop box are delivered to the County Clerk's ballot receiving location by the ballot submission deadline.
  - j) **Potential Action to Issue CIS on CF 20-1084**  
COVID-19 Emergency Eviction Defense Program / Tenant Protections / Legal Defense: Introduced on August 28, 2020 and referred to Ad Hoc Committee on COVID-19 Recovery and Neighborhood Investment.

Project Roomkey Program / Homeless Emergency NonCongregate Shelters / COVID-19 Pandemic: Introduced on August 27, 2020 and referred to Homelessness and Poverty Committee. City Administrative Officer report dated August 21, 2020, relative to the status and occupancy of project Roomkey Program.
  - l) **Potential Action to Issue CIS on CF 20-0002-S141**  
H.R. 6494 (Thompson) / Business Interruption Insurance Coverage Act of 2020 / Viral Pandemics / Forced Closures / Mandatory Evacuations / Public Safety Power Shut-Off: Introduced on August 26, 2020 and referred to Rules, Elections, and Intergovernmental Relations.
