f. Scooter enforcement

Discussion: We are in the very early stages of establishing a SOZ like in Venice. DLANC has been approached by many scooter companies about including them in SOZ. We're kicking off this conversation early and will take a more formal position in Jan 2022. The SOZ only requires LADOT, no need for full city council approval. Rules will be around scooter quantity cap, limits on pickup/dropoff locations and hours of operation, limit the number of companies that can operate. Suggestion to place pickup/dropoff zones next to metro bike stations. Suggestion to make zones more visible and keep them in proximity to intermodal transit options. Suggestion to specify the number of zones per block.

Committee members were instructed to continue information gathering and to email specific ideas and suggestions to the chair. A draft letter will be prepared for January 2022 meeting.
