d. Nuisance issues in front of the Los Angeles Theater Center (514 S Spring St)

Tia Strozer and Senior Lead Officer Linton were present for discussion.

Claudia Oliveira (CO) received multiple complaints about conditions of the theater from residents living in adjacent buildings. Issues are getting worse, with Security Lofts residents needing to be escorted out of concern for safety. The contract for the theater, in its 15th year of 20-year term, was renewed in 2020 for another 30 years (expiring 2056).

David Nealy (member of public): Asked if it's possible to add more staff members that are trained to deal with substance abuse issues.

RR: We have a contract with Urban Alchemy, can potentially ask to expand services into Historic Core.

CO: Said the issues are more about drug sales instead of drug use, that the area has become a hub for sales.

Nicki Genovese, rep from DCA, which is the city agency tasked with maintaining the LATC property, commented that it's the responsibility of the tenant to maintain the front of the property. DCA can't get involved, but has noted and will continue to monitor the situation. Nicki will relay issues to head of the General Services Dept. She has no knowledge of recourse but will follow up and inform us of possible action.

RR suggested we explore what role the NC can take, potentially partner with GSD on solutions e.g. nuisance abatement lighting.

CO: We need to have a cultural change in dealing with this issue, specifically a different view with the tenant operator on accountability.

Jose Valenzuela, operator of LATC, explained that unions currently don't allow performances due to COVID. He explained he's exhausted options, building security can't touch individuals who are loitering, can only ask them to move.

RR will set up a joint meeting with Jose, CO.

MC: Potential upcoming activation of the Trust Building, could help improve conditions. Next steps on item: will continue the conversation in future meetings, maintain correspondence with agencies and DCA.

e. Nuisance issues around CVS at 7th / Spring

Boris (member of public): Manages Haas building, says people are getting access through City Center garage to route around the gates. Situation is heavily deteriorated.

Nish(member of public): Is curious what's going on, doesn't recall seeing anything unusual in the area.

CO: BID power washes every day, up to 2x a day and it's not enough of a deterrent.

Sr. Officer Linton: Has seen complaints about the area, reviewed prior abatement efforts. Met with CVS management pre-COVID, but not since. Has reached out to CVS management, hopes to start having regular meetings again with CVS + Van Nuys building management.. There are 12 buses that stop there now, and MTA is not willing to move bus route because 7th St is a main corridor. LAPD has limited resources, arrest policy limits.

CO: spoke to Captain Morales about having roll calls in these key locations.

Teddian (member of public): Works with buildings in Europe, suggests solution of activating retail to deter loitering.

David N. (member of public): Can we provide incentives for retail operators?

Tia Strozer said she can elevate issues with CVS and LAPD in meetings, and can provide case updates.
