RR motioned to amend fifth paragraph of letter to designate only committing overtime funds for street racing, and to add a statement requesting for traffic control solutions. MC seconded.

Discussion:

Nish K (member of public): Suggested to include a statement specifying using existing funds and only allocating overtime if existing funds are exhausted.

RR: There is no other mechanism to combat the street racing issue within LA City. The police component is necessary. Committed LAPD funds have already been exhausted due to the sheer increase in the amount of street racing occurring in the City.

Keith (member of public): LAPD has a street racing task force. OT will get more officers, but they're also subject to LAPD rules and regulations. Long term, it would be more effective to install physical deterrents, e.g. beautification planters, to create obstacles that prevent them from performing stunts. Misdemeanors have no consequences now.

David (member of public): Why is there not more car impounding?

RR: LAPD are allowed to impound cars for up to 30 days for violators only, not for spectators.

MC: Suggested we install roundabouts, but knows they're expensive. Agrees with idea for adding beautification efforts.

JW: Suggested adding medians on Figueroa that have green space. Also suggested having a reward system for reporting violators.

Nish (member of public): Suggested making comments on LADOT's Downtown Mobility Plan to include traffic calming measures.
