Re: Downtown Los Angeles SOZ - Dockless Parking Zones

To Whom It May Concern:

At our regularly held public meeting on December 13, 2022, the Board of Directors of the Downtown Los Angeles Neighborhood Council ("DLANC") voted to provide the following comments below:

In February of 2022, DLANC sent a letter to LADOT staff in support of initial efforts taken by the department to study the creation of a Special Operations Zone (SOZ) for the Downtown Los Angeles area in Council District 14. After months of community engagement undertaken by the LADOT, DTLA residents and stakeholders are eager to see solutions to better address the management of Dockless Mobility Devices on the Public Right-of-Way (PROW).

Solutions presented by LADOT staff to have docking stations located in the street rather than the sidewalk address many concerns regarding the parking management of devices. As such, as the department continues to finalize the policy and design of these stations, DLANC recommends LADOT consider the following treatments for the placement of docking stations in the PROW:

- Design docking stations with physical corral barriers to prevent scooters and e-bikes from falling into vehicle travel lines
- Provide high visibility markers such as paint, signage, colored K71 Bollards, or stanchions to designate docking stations
- Consider working with the Bureau of Street Services (StreetsLA) Street Transit Amenities Program (STAP) team to integrate STAP furniture assets with docking stations

- Couple and integrate docking stations with existing Metro Bike Stations wherever possible.

Furthermore, DLANC recommends that LADOT consider the ~~additional inclusion of the~~ following recommendations for the placement of specific Dockless Parking Zones on top of the existing identified department locations.

- *Figueroa Boulevard Corridor* to include locations at either the intersection of 2nd and 3rd Streets, Olympic, and Chick Hearn Ct. / 11th Street
- 8th & San Pedro Street
- *2nd Street Corridor* to include locations at either the intersections of Los Angeles Street, Hill Street, and Grand Avenue
- 11th and Grand Avenue
- *7th Street Corridor* to include locations at either the intersections of Broadway, Hill Street, and Santa Fe Avenue
- Olympic and Maple Street
- 5th and Spring Street
- 9th and Olive
