Written and oral testimony will be summarized for the Cannabis Regulation Commission, which will decide whether to issue the license during the public hearing listed below. Written testimony received after the deadline will not be included in the report presented to the Cannabis Regulation Commission. Please note that this meeting is designed solely for the community to express any concerns or support related to the application. There will be no discussion or decision made during this meeting.

## Public Hearing Information

The Cannabis Regulation Commission (CRC) shall conduct a public hearing in-person at the location below. At the hearing, the CRC will consider public comment regarding the application and decide whether to issue the commercial cannabis license. An individual's testimony will be limited to one (1) minute of general public comment per meeting and one (1) minute of public comment per agenda item, up to two (2) minutes per meeting. In total, an individual shall be limited to three (3) minutes of public comment per meeting. The Commission may limit the total amount of time for public comment.
